3. SECURITY DEPOSIT

A pre-authorization hold of \$500.00 will be placed on the Renter's credit or debit card at pickup via Square. This is NOT a charge — funds are only captured if damage, theft, or policy violations occur. The hold is released in full upon timely, undamaged return.

4. RENTER RESPONSIBILITIES

1. Use the equipment only for lawful personal recreational purposes.
2. Wear the provided helmet and protective gear at all times while riding.
3. Not allow any other person to operate the rented equipment.
4. Not use the equipment on highways, in water, or in violation of local laws.
5. Return the unit undamaged by the agreed return time.
6. Immediately notify EUC Dojo of any accident, damage, or theft.

5. THEFT OR NON-RETURN

If the unit is not returned within two (2) hours of the agreed time without prior notice, EUC Dojo may capture the full deposit, file a police report using the Renter's ID on file, and pursue civil action for the full replacement value. EUC Dojo may use GPS tracking or other methods to locate the unit.

6. DAMAGE LIABILITY

The Renter is fully responsible for any damage beyond normal wear and tear. Costs exceeding the deposit will be charged to the card on file. Unit condition is documented with photos before each rental — the Renter agrees to that condition at pickup.

7. ASSUMPTION OF RISK & LIABILITY WAIVER

THE RENTER ACKNOWLEDGES THAT RIDING AN ELECTRIC UNICYCLE INVOLVES INHERENT RISKS INCLUDING FALLS, COLLISIONS, SERIOUS INJURY, OR DEATH, AND VOLUNTARILY ASSUMES ALL SUCH RISKS. To the maximum extent permitted by law, the Renter releases EUC Dojo, its owners, employees, and agents from any claims arising out of injury, damage, or loss during the rental period. The Renter confirms they are 18+, in good physical health, and capable of operating the equipment.

8. SAFETY GEAR

The Renter acknowledges receiving a helmet, wrist guards, and knee pads at no charge and agrees to wear them while riding. Refusal to wear safety gear voids any claim against EUC Dojo for resulting injuries.

9. GOVERNING LAW

This Agreement is governed by the laws of the State of Florida. Disputes shall be resolved in Orange County, Florida.
